Otherwise Samuel Tovey of Milk Street in the City of Bristol accountant hereby revoking all wills and other testamentary dispositions by me heretofore made do publish this to be my last will and testament I give and bequeath unto my dear wife Mary Ann Tovey all my household goods and furniture plate linen and china books prints and pictures and all other xx articles of domestic use or descripttion to and for her own proper and absolute use and benefit I give and devise my precious house number 86 Stokes Croft in the City of Bristol now in the occupation of my son Charles Tovey to my said son Charles to hold to him his heirs and assigns for ever subject to any mortgage debt that may be charged thereon and the interest thereof and also subject and charged with an annuity of ten pounds to my said dear wife during her life and widowhood which I direct my son Charles to pay to her by equal half yearly instalments the first to be paid at the expiration of six calendar months from my decease and immediately upon the death or marriage of my said wife the said messuage and premises to rest in my son Charles Tovey his heirs and XXXx subject only to the mortgage and interest absolutely I give and bequeath unto my esteemed friend Michael Hinton Castle Esquire and my son Charles Tovey my household messuage with the appurtenances Xx and being number 14 in Park Street Bristol in the occupation of Robert Wxxx as tenant to me at the yearly rent of seventy pounds under a lease from me for seven years to hold the same unto the said Michael Hinton Castle and Charles Tovey their executors administrators and assigns upon trust from time to time to let the same messuage and premises and receive the rents Xxx and after the payment of the expenses for keeping the same in reasonable repair and insured against loss by fire do and shall pay the net proceeds thereof unto or permit my said wife Mary Ann Tovey to receive the same for her own proper use during her life in case she shall so long continue my widow and after the decease or marrying again of my said wife any said messuage and premises in Park Street shall be in trust for my four daughters Mary Jane Tovey Hellen Elizabeth Tovey otherwise Hannah Elizabeth Tovey in which latter name her baptism has been by mistake registered Elizabeth Tovey and Margaret Anne Tovey in equal shares as tenants in common and their respective executors administrators and assigns to rest in them respectively on Their respectively attaining the age of twenty one years or marrying under That age with consent of the trustees for the time being xxxx but in case either of my said daughters shall die in the life time of my said wife or whilst she shall continue my widow or without having attained the age of twenty one years or having been married with such consent as aforesaid then the same shall be in trust for the survivors of them equally or wholly if there shall be but one such survivor provided and it is my will that if either of my said daughters shall so die leaving lawful issue her surviving then such issue shall take and be entitled to the same to which his her or their parent would have been entitled if living and if there be more than one such issue then equally between them I give and devise unto and to the use of the said Michael Hinton Castle and Charles Tovey their heirs and assigns my two freehols messuages and premises in Broad Street in the Parish of Saint Philip and St Jacob
